

2017 Fuel with Dew Sweepstakes

OFFICIAL RULES

No purchase or payment necessary. A purchase or payment of any kind will not increase your chances of winning. Message and data rates may apply. Void where prohibited.

1. Enter to win four (4) grandstand tickets to the NASCAR race at the Chicagoland Speedway, September 17, 2017, and four (4) meet-and-greets with Kasey Kahne (as defined in section 5) when you participate in the 2017 Fuel with Dew Sweepstakes during the Entry Period (as defined in section 4).
2. **ELIGIBILITY:** The 2017 Fuel with Dew Sweepstakes (the "Giveaway") is open only to legal residents of the United States residing in Illinois, Michigan, South Dakota, or Wisconsin, who are 18 years of age or older at the time of entry. Void where prohibited by law. Employees of Wis-Pak, Inc., WP Beverages, LLC, its Shareholders & distributors, or any other company or individual involved with the design, production, execution, or distribution of the Giveaway and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each employee are not eligible. One (1) text message will be required to participate. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. Limit one (1) entry per day per person. A "day" is defined as a twenty-four (24) hour time period beginning at 12:00:00 a.m. (midnight) CST and ending at 11:59:59 p.m. CST. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes.

In the event of a dispute over the identity of a potential winner, text message entry will be declared made by the authorized account holder of such wireless phone number submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such email address or wireless phone number. 5. PRIZE DETAILS: One (1) prize is available to be won.

Grand Prize: One (1) "Grand Prize" is available to be won. The potential winner will be notified via text message provided at time of entry.
