

**2025 Pepsi x NFL x Christian Watson Autographed Football Giveaway (“Sweepstakes”)  
Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. DATA RATES MAY APPLY TO ENTRIES MADE VIA MOBILE DEVICE. INTERNET ACCESS REQUIRED.**

**THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE U.S. RESIDING IN THE STATES OF WISCONSIN AND ILLINOIS, WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AT TIME OF ENTRY. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES AND WILL BE GOVERNED BY U.S. LAW AND THE STATE OF WISCONSIN. DO NOT ENTER THIS SWEEPSTAKES UNLESS YOU ARE ELIGIBLE AND LOCATED IN THE UNITED STATES, ALL AT THE TIME OF ENTRY.**

**1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 17, 2025 at 12:01 a.m. Central Time (“CT”) and ends on May 4, 2025 at 11:59 p.m. CT (“Sweepstakes Period”). The time clock of the Sweepstakes Sponsor’s (defined below) computer is the official timekeeping device for the Sweepstakes.

**2. HOW TO ENTER:** During the Sweepstakes Period, you can enter via the following methods: **(a) SCAN THE QR CODE ON POS:** Use your smart phone, or internet enabled device, to scan the QR code located on Point Of Sale elements in Woodman’s stores. Follow the on-screen instructions for registering, properly completing, and submitting an entry. Participants must have a smart phone or other web-enabled device with a camera feature or code-reader application and may incur standard data charges from their wireless service provider. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. By entering this Sweepstakes the entrant is consenting to receive text, phone, and/or email messages regarding the Sweepstakes; **(b) INTERNET:** Visit [www.wpbpepsi.com/watsonfootballgiveaway](http://www.wpbpepsi.com/watsonfootballgiveaway) and follow the on-screen instructions to properly complete and submit an online entry by May 4, 2025.

Limit one (1) entry per person/email address per day, regardless of method of entry. A “day” is defined as a twenty-four (24) hour time-period beginning at 12:00:00 a.m. (midnight) CT and ending at 11:59:59 p.m. CT of the same day. The time clock of the Sweepstakes sponsor is the official clock for this Sweepstakes.

All entrants must have a valid email address. The name of the person submitting the entry into the Sweepstakes must be the authorized account holder of the email address used to enter, otherwise, entry may be deemed void. Multiple entrants may not share the same email address. In the event of a dispute over the identity of an entrant, entry will be declared to be made by the authorized account holder of the email address used during the entry process. A potential winner may be required to provide identification sufficient to show that they are the authorized account holder of such email address.

Each entry must be manually keystroked and/or manually entered by the individual entrant. Automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified and transmissions from any such scripts, macros, bots or sweepstakes services or related email addresses or IP addresses may be blocked. If it is discovered that an entrant used multiple email addresses, phone numbers, and/or mailing addresses, or manipulated such information for the purpose of

obtaining more than one (1) entry per day, that person will be disqualified and any prize won, shall be forfeited.

It is solely the responsibility of the entrant to notify the Sponsor in writing if the entrant changes his or her e-mail, wireless phone number, or postal address during the Sweepstakes Period. All entries become the property of the Sponsor and will not be acknowledged or returned.

**ELIGIBILITY:** The Sweepstakes is open only to legal U.S. residents residing in Wisconsin and Illinois who are eighteen (18) years of age or older at the time of entry. **3. PRIZE DETAILS:** Twenty (20) Prizes will be awarded, consisting of one (1) Christian Watson autographed football. Approximate Retail Value (ARV): \$50.00. No alternate prizes are available. Limit one (1) prize per name, address, and/or household.

**4. RANDOM DRAWING:** Potential winner(s) will be selected in a random drawing from among all eligible entries received throughout the Sweepstakes Period. Odds of winning depend upon the total number of eligible entries received. Drawing will occur on or about May 7, 2025. All prizes will be awarded. Sponsor's decisions as to the operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes.

**5. WINNER NOTIFICATION:** Potential Sweepstakes winner(s) will be notified by the Sponsor via email at the email address provided upon entry within two (2) business days of the drawing date, and will be required to claim the prize (by providing his/her phone number and/or mailing address, if not already provided) within seventy-two (72) hours or prize may be forfeited and awarded to alternate winner. If (a) a potential winner does not properly claim their prize (as instructed in the Notification); (b) a Notification or prize is returned as undeliverable; or (c) a potential winner cannot be verified or is otherwise unable to accept the prize as stated, prize may be forfeited and awarded to an alternate winner at Sponsor’s sole discretion. Any portion of a prize not accepted by winner will be forfeited. Upon forfeiture for any reason as stated in these Official Rules, no compensation will be awarded. Sponsor is not responsible for suspended or discontinued Internet or wireless service or a change in winner’s phone number or email address which may result in a potential winner not receiving initial prize notification. Once potential winner notification is confirmed to Sponsor, the potential prize winner may be sent an Affidavit of Eligibility and Liability/Publicity Release to be signed and returned within the number of days indicated on the Affidavit. Receiving a prize is contingent upon compliance with these Official Rules.

**6. LIMITATIONS OF LIABILITY:** Sponsor and Promotion Parties assume no responsibility or liability for (a) any incorrect or inaccurate entry information, or for any faulty or failed electronic data transmissions; (b) any unauthorized access to, or theft, destruction, or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation, or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, cameras, computers, or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of any network or wireless service, the Internet or website, or any combination thereof; (e) suspended or discontinued Internet, wireless, or land line phone service; (f) any injury or damage to participants or to any other person's computer or mobile device which may be related to or resulting from any attempt to participate in the Sweepstakes or download of any materials in the Sweepstakes; (g) any change in a potential winner's email address which may result in a potential winner not receiving a Notification; or (h) any undelivered or unanswered emails, including without limitation, emails that are not received because of a potential winner's privacy or spam filter setting which may divert any Sweepstakes email, including any Notification, to a spam or junk folder. In such event, Sponsor shall immediately suspend all drawings and prize awards, and Sponsor reserves the right to award any remaining prizes (up to the total set forth in these Official Rules) in a manner deemed fair and equitable by Sponsor, such as by way of example and not by way of limitation, in a random drawing from among all eligible, non-suspect entries received up to the time of the impairment, and Sponsor and Promotion Parties shall not have any further liability to any participant in connection with the Sweepstakes. Sponsor may modify and amend these Official Rules as they may appear online from time to time during the Promotion for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.

**7. VERIFICATION:** All Sweepstakes entries are subject to verification by the Sponsor at the sole discretion of the judges and anti-fraud detection measures, entries found to be photocopied, reproduced, altered, forged, defaced, tampered with, mutilated, stolen, unissued, unauthorized, traded, bartered, sold, illegitimately obtained, or illegal in any way will be disqualified.

**9. GENERAL CONDITIONS:** This Sweepstakes is governed by the laws of the United States and of the State of Wisconsin without respect to conflict of law doctrines. Prize winner is solely responsible for any and all taxes and related expenses on the prize and may receive an IRS Form 1099 for the ARV of the prize. Unclaimed prizes will not be awarded. Sponsor reserves the right to substitute a prize of equal or greater value in the event a prize or any portion of a prize becomes unavailable. No substitution of prize is offered, no transfer of prize to a third party is permitted, and non-cash prizes may not be redeemed for cash value except at Sponsor's sole discretion. All other expenses on the receipt and use of the prize not specifically mentioned herein are solely the responsibility of the winner. Any difference between the stated value of any prize and the actual retail value will not be awarded. All federal, state, and local laws and regulations apply.
